Executive Summary

On March 7, 2023, we presented the Committee's Annual Report (March 2022 – February 2023) to the Board of Trustees in public session.

The following is a summary of the Committee's activities from March 2023 through February 2024.

The Committee met three times during this period and made site visits to Katella High School, Anaheim High School and Magnolia. The Committee met on the following dates:

- > We received design and construction project updates for various Measure H projects
- > We received final cost reports for completed Measure H projects
- We received and reviewed project budgets
- > We received and reviewed the list of upcoming Measure H projects and preliminary budgets
- We received and reviewed the expenditure reports related to the Anaheim Union High School District (Orange County, California) General Obligation Bond, Election of 2014 - Series 2015 (\$63.5M), Series 2018 (\$83M) and Series 2019 (\$102M)



Executive Summary

Specific Meeting Topics

- On June 15, 2023
 - We visited Katella High School to tour the Pool Renovation Project that is under construction.
 - We observed the demolition of the existing pool and deck, which were in progress.
 - We also toured the DROPS-Site Improvement Project which was completed in 2017, with its new drought tolerant landscaping, hardscape and canopies to observe the upkeeping of the facility.
- On January 17, 2024
 - We visited Anaheim High School to tour the completed Track and Field Project.
 - We toured the completed new track, field, bleachers and surrounding hardscape and landscape.



Executive Summary

Specific Meeting Topics (continued)

- On February 22, 2024
 - We visited Magnolia High School to tour the completed projects to view the upkeeping of the occupied facilities:
 - Pool Renovation Project. We toured the completed pool, deck and equipment room.
 - Shower/Locker Room Project. We toured the completed boys' and girls' locker rooms, athletic training rooms and wrestling room.
 - Music Building. We toured the completed /modernized Music Building.
 - We visited Magnolia High School to tour the soon to be completed projects:
 - New Administration and Cybersecurity Classroom Building Project. We observed the new building and its surrounding sitework that are under construction.
 - Art Classrooms and Courtyard. We observed the modernization of the facility that is under construction.
 - We received a presentation and reviewed the Financial and Performance Audits for the year ending June 30, 2023, that was prepared by Eide Bailly, the District's auditing firm. The auditor stated that 82% of Measure H expenditures were tested. The final audit reports were presented to the Board of Trustees on January 18, 2024.



Annual Report

Based on our review of the Financial and Performance Audit Report dated June 30, 2023, project updates and site visits, we are confident the AUHSD is expending the bond proceeds only for the purposes as set forth in the Measure H Bond Program and not for other purposes. We are satisfied with efforts being made to complete all projects as planned and in a cost-effective manner, and will continue to diligently monitor those efforts.

The Anaheim Union High School District Board of Education established the Citizens' Oversight Committee (COC) by Resolution No. 2014/15-B-02. The Committee is established under the guidelines of Measure H Bond election. Measure H was approved by the voters on November 4, 2014, and authorized the issuance of \$249,000,000 in general obligation bonds for capital improvement projects throughout the District.

<u>Purpose</u>

The purpose of the COC is to inform the public, at least annually in public session, concerning the expenditure of bond proceeds as approved by the voters on November 4, 2014. Bond proceeds may be expended only on capital improvement projects as defined by Exhibit B of Resolution No. 2014/15-B-02.

The specific activities of the COC includes the following:


- 1. Review, revisions and approval of the Committee Bylaws

- 8. Adherence to the Brown Act requirements of publicized and open meetings


