Executive Summary

The following is a summary of the Committee's activities from March 2019 through February 2020.

On March 5, 2019, we presented the Committee's Annual Report (March 2018 – February 2019) to the Board of Trustees in public session.

The Committee met four times during this period and made site visits to Cypress High School, Savanna High School, and Dale Junior High School. The Committee met on the following dates:

- We received design and construction project updates for various Measure H projects
- We received final cost reports for completed Measure H projects
- We received and reviewed project budgets
- We received and reviewed the list of upcoming Measure H projects and preliminary budgets
- We received and reviewed the expenditure reports related to the Anaheim Union High School District (Orange County, California) General Obligation Bond, Election of 2014 - Series 2015 (\$63.5M), Series 2018 (\$83M) and Series 2019 (\$102M)



Executive Summary

Specific Meeting Topics

- On May 30, 2019:
 - We visited Cypress High School to observe the "completed" site improvement project at that school.
- On August 6, 2019:
 - We received information on the impending sale of the final Measure H bond series (2019) in an estimated amount of \$102M.
 - We were informed that the District was exploring the possibility of placing another bond measure on the 2020 ballot. The COC was invited to participate in a Community Colloquium on August 17, 2019.
 - We visited Savanna High School to observe the progress of the site improvement project at that school.
- On November 14, 2019:
 - We received the resignation of two committee members due to personal reasons.
 - We visited Savanna High School to observe the substantial progress of the site improvement component of the work and the renovation of the shower/locker rooms.
- On February 12, 2020
 - We received a presentation and reviewed the Financial and Performance Audits for the year ending June 30, 2019, that was prepared by EideBailly, the District's auditing firm.
 - We visited Dale Junior High School to observe the progress of the modernization work. We toured
 the renovated classrooms and labs.

Based on our review of the Financial and Performance Audit Report dated June 30, 2019, project updates and site visits, we are confident the AUHSD is expending the bond proceeds only for the purposes as set forth in the Measure H Bond Program and not for other purposes. We are satisfied with efforts being made to complete all projects as planned and in a cost-effective manner, and will continue to diligently monitor those efforts.

The Anaheim Union High School District Board of Education established the Citizens' Oversight Committee (COC) by Resolution No. 2014/15-B-02. The Committee is established under the guidelines of Measure H Bond election. Measure H was approved by the voters on November 4, 2014, and authorized the issuance of \$249,000,000 in general obligation bonds for capital improvement projects throughout the District.

<u>Purpose</u>

The purpose of the COC is to inform the public, at least annually in public session, concerning the expenditure of bond proceeds as approved by the voters on November 4, 2014. Bond proceeds may be expended only on capital improvement projects as defined by Exhibit B of Resolution No. 2014/15-B-02.

- 3. Visits to construction sites
- 4. Attend regular meetings as a committee
- 5. Review of various reports and information including:
 - Annual performance and financial audits
 - Quarterly expenditure reports
 - Construction project updates
 - Planning status of future construction projects utilizing Measure H Bond funds
 - Various staff reports

- 6. Review of bond series issuance details
- 7. Review of efforts of the District to maximize bond revenues by accessing state matching funds, and implementing cost-savings measures


